## Past Year in Review

Serra Foundation of Canada assists Serra to fulfill its objectives of promoting and affirming vocations in the Catholic Church by supporting and complementing the prayers and actions of Serrans. Although Serra is not a fund-raising organization it can receive two different types of gifts:

1) "Unrestricted gifts" which are monetary gifts received from the memorial/gift cards, the annual appeal and other charitable activities including Toronto's Ordinandi Dinner Gala Event. Unrestricted gifts are used to fund grants for general vocations activities.

2) "Restricted gifts" which are monetary gifts received from a donor with instructions that the gift be used for a particular vocation activity. The Foundation receives from the Bedolfe Foundation annually a restricted gift which is designated for payment to the Toronto Downtown Serra Club for its vocation activities. Both types of gifts are welcomed by the Foundation as they enhance awareness of Serra's vocations apostolate in Canada.
